Technical Report

EMO

YARA has been trying to acquire a small bus, van, etc to configure and use as a mobile communications centre for sometime. That line of inquiry has proven unsuccessful. However the great news is that YG/EMO has given YARA a fully enclosed tandem 20ft trailer. It has two fold down tables/work benches, is wired, has a generator and looks very clean. The consensus is that is likely a better option because it can be dropped at a scene with operators and still leave our suburban available for other tasks. The next step is to establish a committee to explore options for internal setup and layout. VY1AK has some pictures and the details. What a great acquisition!

The idea has come up to start an NTS net (National Traffic System) net. This could further our ability, knowledge and skills in emergency traffic handling using all modes including data communications.
